The Town of Caledon is providing a tax assistance program for qualified low-income seniors and low-income persons with disabilities in accordance with Town of Caledon By-law No. 2010-028 as amended by By-law No. 2011-023 which allows for a tax reduction of \$450 against the residential real property taxes imposed by the Town provided that the by-laws' eligibility criteria are met.

**All applications must be made by April 30<sup>th</sup> of the current taxation year.**

#### Low Income Disabled Eligibility Requirements

- I am and/or my spouse is a person with disabilities and in receipt of benefits provided under the *Ontario Disability Support Program Act (ODSPA)*. Please provide a copy of the most recent benefits statement for O.D.S.P.
- Have been continuously assessed as the owner *and* reside on residential real property within the Town of Caledon for a period of not less than five years immediately preceding April 30 of the taxation year
- I have attached my most recent O.D.S.P. benefit statement to this application
